# SECTION 4 – FIRST AID MEASURES

# 4.1 Description of first aid measures

**Inhalation:** If product mist or vapor causes respiratory irritation or distress, move the exposed person to fresh air immediately. If breathing is difficult or irregular, administer oxygen; if respiratory arrest occurs, start artificial respiration by trained personnel. If unconscious, maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband. If symptoms persist or if the victim feels unwell, seek medical attention.

**Eyes:** Immediately flush eyes with large amounts of water or saline solution for at least 15 minutes, occasionally lifting the upper and lower lids. Remove contact lenses, if present and easy to do, after first 2 minutes and continue rinsing. If irritation persists seek medical attention, preferably from an ophthalmologist.

**Skin:** Flush skin with large amounts of water while removing contaminated clothing. Wash the affected area with soap and water followed by thorough rinsing. Wash contaminated clothing and shoes before reuse. If irritation persists, seek medical attention.

**Ingestion:** Rinse mouth with water if the victim is conscious. Remove dentures if present. DO NOT induce vomiting unless directed to do so by medical personnel. Vomiting may occur spontaneously. To prevent aspiration of material into the lungs, lay the victim on one side with the head lower than the waist. Never give anything by mouth to an unconscious or convulsing person. Do not leave the victim unattended. Seek immediate medical attention.

# 4.2 Most important symptoms and effects, both acute and delayed

# Potential health symptoms and effects

Eyes: May cause eye irritation with inflammation, discomfort, tearing and blurred vision. Vapor or mist can cause eye irritation.

**Skin:** Causes skin irritation with localized redness, itching and discomfort. Prolonged contact with unprotected skin may cause defatting of the skin and dermatitis. May be harmful if absorbed through the skin.

**Inhalation:** Harmful if inhaled. Causes respiratory tract irritation. Inhalation of high concentrations (>200 ppm) of toluene are clearly associated with central nervous system encephalopathy, headache, dizziness, nausea, drowsiness, depression, lassitude, (weakness, exhaustion), incoordination, transient memory loss and impaired reaction time. Extreme exposures may cause irregular heartbeats, which can be fatal.

**Ingestion:** Harmful if swallowed. Causes irritation of the digestive tract with nausea, vomiting, abdominal pain and diarrhea. May cause central nervous system depression characterized by excitement, followed by headache, dizziness, drowsiness and nausea. Advanced stages may cause collapse, unconsciousness, coma and possible death due to respiratory failure. May cause liver and kidney damage. This material can get into the lungs during swallowing or vomiting causing lung inflammation and chemical pneumonitis, which may be fatal. Symptoms of aspiration into the lungs include coughing, gasping, choking, shortness of breath, bluish colored skin, rapid breathing and rapid heart rate.

**Chronic**: Individuals with pre-existing skin conditions and respiratory disorders may be more susceptible to the effects of this product. Chronic skin contact may cause defatting, dermatitis or aggravate existing skin problems. Repeated exposure in combination with constant, loud noise can cause hearing loss and dizziness. Toluene abuse has been linked to kidney disease. Intentional abuse of toluene vapors has been linked to damage to the brain, liver, kidneys and to death. Repeated inhalation exposure of toluene to animals causes histological changes in the brain and degeneration of heart tissue. Effects may be delayed. Exposure to this product may harm the unborn child. Refer to Section 11.2.

Chronic hydrocarbon abuse (e.g. sniffing solvents such as toluene) has been associated with irregular heart rhythms and potential cardiac arrest. Intentional abuse of toluene has been linked to damage to the brain, liver and kidneys and can be fatal.

# 4.3 Indication of any immediate medical attention and special treatment needed

# Advice to doctor and hospital personnel

If ingested, this material presents a significant aspiration and chemical pneumonitis hazard. Induction of emesis is not recommended. Consider active charcoal and/or gastric lavage. If patient is obtunded, protect the airway by cuffed endotracheal intubation or by placement of the body in a Trendelenburg and left lateral decubitus position.

If inhaled, this material sensitizes the myocardium to the effects of sympathomimetic amines. Epinephrine and other sympathomimetic drugs may initiate cardiac arrhythmias in individuals exposed to this material. Administration of sympathomimetic drugs should be avoided

# **SECTION 5 – FIRE FIGHTING MEASURES**

# 5.1 Extinguishing media

**Suitable methods of extinction:** Use extinguishing media such as water spray or fog, carbon dioxide, foam and dry chemical. **Unsuitable methods of extinction:** Water jets or streams may spread the fire. This material floats on water.

# 5.2 Special hazards arising from the substance or mixture

Highly flammable liquid and vapor! Vapors are heavier than air and can travel along the ground to a source of ignition and flash back. Vapors can spread along the ground and collect in low or confined areas. Exposure to ignition sources (e.g. cell phones) can ignite vapors, causing a flash fire. Closed containers may explode due to the buildup of pressure when exposed to extreme heat. During emergency conditions overexposure to decomposition products may cause a health hazard. Symptoms may not be immediately apparent or may be delayed. Obtain medical attention.

**Explosion hazards**: Avoid sources of ignition. Vapors may form an explosive mixture with air, especially in confined spaces. Ground and bond containers in storage and when container is in use.

# 5.3 Advice to firefighters

Firefighters should wear full bunker gear including NIOSH-approved positive pressure self-contained breathing apparatus to protect against potential hazardous combustion or decomposition products and oxygen deficiencies. Water may be used to cool closed containers to prevent pressure buildup and possible autoignition or explosion when exposed to extreme heat. Be aware that burning liquid will float on water. Firefighters should control runoff to prevent environmental contamination. Notify appropriate authorities of potential fire and explosion hazard if liquid enters sewers or waterways.

# SECTION 6 – ACCIDENTAL RELEASE MEASURES

# 6.1 Personal precautions, protective equipment and emergency procedures

Evacuate non-essential personnel. Wear appropriate protective clothing and equipment designated in Section 8.2. Ventilate the area. Remove all sources of ignition. NO SMOKING. Clean up spills immediately. Spill creates a slip hazard.

# 6.2 Environmental precautions

Avoid dispersal of spilled material or runoff and prevent contact with soil and entry into drains, sewers or waterways. Use water sparingly to minimize environmental contamination and reduce disposal requirements.

# 6.3 Methods and materials for containment and cleaning up

Approach spill from upwind direction. DO NOT flush spill down the drain. Cover drains and contain spill. Cover spill with a large quantity of inert absorbent. Do not use combustible material such as sawdust. Collect material using non-sparking tools and place into an approved container for proper disposal. Observe possible material restrictions (Sections 7.2 and 10.5). Do not allow material or runoff from rinsing contaminated areas to enter floor drains or storm drains and ditches that lead to waterways. Dispose of via a licensed waste disposal contractor.

If spilled on water remove with appropriate methods (e.g. skimming, booms or absorbents). In case of soil contamination, remove contaminated soil for remediation or disposal in accordance with local regulations.

In the USA discharges or spills of material on waters of the United States, their adjoining shorelines or into conduits leading to surface waters must be reported to the National Response Center at 800-424-8802.

# SECTION 7 – STORAGE AND HANDLING

# 7.1 Precautions for safe handling

Wear all appropriate personal protective equipment specified in Section 8.2. Do not get in eyes or on skin or clothing. Do not inhale mist or vapor. NO SMOKING. If normal use of material presents a respiratory hazard, use only adequate ventilation or wear an appropriate respirator. Open containers slowly to control possible pressure release. Wash contaminated clothing and shoes thoroughly before reuse.

# Advice on protection against fire and explosion

Keep away from heat and sources of ignition. To avoid fire or explosion, dissipate static electricity during transfer by grounding and bonding containers and equipment before transferring material. Vapors are heavier than air and can travel along the ground to a source of ignition and flash back.

# 7.2 Conditions for safe storage, including any incompatibilities

Store in dry, cool, well-ventilated areas away from incompatible materials (see Section 10.5), food and drink. Keep away from heat and ignition sources. Transfer only to approved containers having correct labeling. Keep containers tightly closed when not in use. Protect containers against physical damage. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Containers are hazardous when empty as they contain product residue. Do not cut, drill, weld, braze, solder grind or perform similar operations on or near empty containers. Use appropriate containment to avoid environmental contamination. Ventilate closed areas. Keep out of reach of children.

A "skin" notation following the inhalation exposure guideline refers to the potential for dermal absorption of the material, including eyes and mucous membranes, either by direct contact with vapors or by direct skin contact. It is intended to alert the reader that inhalation may not be the only route of exposure and that measures to minimize dermal exposure should be considered.

# 8.2 Exposure controls

**Engineering measures:** Technical measures and appropriate working operations should be given priority over the use of personal protective equipment. Use adequate ventilation. Local exhaust is preferable. Refer to Section 7.1.

**Individual protection measures:** Wear protective clothing to prevent repeated or prolonged contact with product. Protective clothing needs to be selected specifically for the workplace, depending on concentrations and quantities of hazardous substances handled. The chemical resistance of the protective equipment should be enquired at the representative supplier.

**Hygiene measures:** Facilities storing or using this material should be equipped with an eyewash station and safety shower. Change contaminated clothing. Preventive skin protection is recommended. Wash hands thoroughly after use, before eating, drinking, smoking or using the lavatory.

Eye/face protection: Wear safety glasses with unperforated side shields or protective splash goggles during use.

Hand protection: Wear gloves made of Butyl rubber, chlorinated polyethylene, Viton<sup>™</sup> or those recommenced by glove supplier for protection against materials in Section 3. Gloves should be impermeable to chemicals and oil. Breakthrough time of selected gloves must be greater than the intended use period.

Skin protection: Wear protective clothing. Wear protective boots if the situation requires.

**Respiratory protection:** Always use an approved respirator when vapor/aerosols exceed permissible exposure limits. Where risk assessment shows air-purifying respirators are appropriate use a half-mask respirator with multi-purpose combination (US) or type ABEK (EN 14387) respirator cartridges as a backup to engineering controls. If the respirator is the sole means of protection, use a full-face supplied air respirator. Use respirators and components tested and approved under appropriate government standards such as NIOSH (US) or CEN (EU). Follow OSHA respirator regulations found in 29 CFR 1910.134 or European Standard EN 149.

Environmental exposure controls: Do not empty into drains.

PPE must not be considered a long-term solution to exposure control. PPE usage must be accompanied by employer programs to properly select, maintain, clean fit and use. Consult a competent industrial hygiene resource to determine hazard potential and/or the PPE manufacturers to ensure adequate protection.

# **11.2 Further information**

Toluene (CAS #108-88-3): IARC, Group 3 carcinogen - *Not classifiable as to its carcinogenicity to humans*. Not listed as a carcinogen by ACGIH, NTP or OSHA. Breathing high levels of toluene during pregnancy has been shown to result in children with birth defects and to retard mental abilities and growth. There is evidence that exposure to toluene at work is associated with spontaneous abortion.

Case studies of persons abusing toluene suggest isolated incidences of adverse effects on the fetus including birth defects. Several studies of workers suggest long-term exposure may be related to small increases in spontaneous abortions and changes in some gonadotropic hormones. However, the weight of the evidence does not indicate toluene is a reproductive hazard to humans. Studies in laboratory animals indicate some changes in reproductive organs following high levels of exposure, but no significant effects on mating performance or reproduction were observed. In an epidemiologic study of toluene and pregnancy, occupational exposures to toluene were said to be associated with an increased incidence of renal, urinary, gastrointestinal and cardiac anomalies. Fetotoxicity (reduced fetal weight), behavioral effects (effects of learning and memory) and

hearing loss (in males) were observed in the offspring of rats exposed to inhalation of toluene, in the absence of maternal toxicity.

Handle in accordance with good industrial hygiene and safety practice.
