#### 4. First-aid Measures

**FIRST AID - EYE CONTACT:** Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed.

FIRST AID - SKIN CONTACT: Wash skin with soap and water. Remove contaminated clothing. Get medical attention if irritation develops or persists.

## 5. Fire-fighting Measures

## 6. Accidental Release Measures

#### PERSONAL PROTECTION

## 10. Stability and Reactivity

**CONDITIONS TO AVOID:** Avoid temperatures above 120 ° F. Avoid contact with strong acid and strong bases. Avoid all possible sources of ignition.

EFFECTS OF OVEREXPOSURE - EYE CONTACT: Causes Serious Eye Irritation

**EFFECTS OF OVEREXPOSURE - INHALATION:** Harmful if inhaled. High gas, vapor, mist or dust concentrations may be harmful if inhaled. Avoid breathing fumes, spray, vapors, or mist. High vapor concentrations are irritating to the eyes, nose, throat and lungs. Prolonged or excessive inhalation may cause respiratory tract irritation.

**EFFECTS OF OVEREXPOSURE - CHRONIC HAZARDS:** IARC lists Ethylbenzene as a possible human carcinogen (group 2B). Contains Calcium Silicate (Wollastonite), which is an IARC 3 Agent "unclassifiable as to carcinogenicity to humans" via inhalation. Inhalation exposure to Calcium Silicate is not anticipated through brush application nor normal use. Calcium Silicate is NOT classified as a carcinogen by NIOSH, ACGIH, NTP nor OSHA. Overexposure to xylene in laboratory animals has been associated with liver abnormalities, kidney, lung, spleen, eye and blood damage as well as reproductive disorders. Effects in humans, due to chronic overexposure, have included liver, cardiac abnormalities and nervous system damage. Contains Titanium Dioxide. Titanium Dioxide is listed as a Group 2B-"Possibly carcinogenic to humans" by IARC. No significant exposure to Titanium Dioxide is thought to occur during the use of products in which Titanium Dioxide is bound to other materials, such as in paints during brush application or drying. Risk of overexposure depends on duration and level of exposure to dust from repeated sanding of surfaces or spray mist and the actual concentration of Titanium Dioxide in the formula.
